Description of the problem

Starkling LED laryngoscope handles have been found not to illuminate.

- Starkling e.K. has been made aware that the LED handles / Spare LEDs (devices) extinguish within 60 seconds of continuous illumination when used with some commercially available batteries and are permanently damaged as a result.
- This may pose a potential risk for new patients, if this happens during intubation.
- There is no risk involved for patients who have already been treated with this device previously.
- According to the instructions for use, it is necessary to check the function
 of all laryngoscope handles at least after each reprocessing cycle by
 illuminating them. It is common practice to perform function tests daily and
 after each battery change by visual inspection. It is also common practice
 to have backup devices ready when performing intubations!



 If the handle does not light up, goes out or is only dimly lit during the function check, it is recommended that the backup device is also subjected to a functional check for 60 seconds to avoid a delay in treatment and/or difficult/unsuccessful intubation in an emergency.

Advise on action to be taken

- 1. If you have purchased any of these devices, please locate and quarantine the devices with lot numbers listed in the table above. The tradename "STARKLING", the product number and lot number can be found on both the outer box and on the LED handle / Spare LED (device).
- 2. Please ensure this Field Safety Notice (FSN) has been communicated to all users.
- 3. If you have any devices as listed, please complete and return the Acknowledgment and Response Form (last 2 pages) of this notice to Starkling e.K. indicating the quantities for each lot. Arrangements for return, subsequent credit/replacement and/or spare parts replacement of these devices will then be given.
- 4. Even if you have no affected devices, you are still requested to complete and return the Acknowledgment and Response Form (last 2 pages) of this notice to Starkling e.K. indicating Zero stock.
